From: **Village League to Save Incline Assets, Inc.**

Subject: **Channel 4 TV Coverage this afternoon**

Dear Property Owners,

If you happen to open this email before 5 PM today be sure and tune in TV Channel 4. Their reporter Ellen from Channel 4 is doing a piece on the Incline Property Tax Revolt at some point in the 5 PM news today. She interviewed a small group of Incline property owners on the subject of the huge property tax assessments and will be reporting on the views of the assessor and comments from Incline citizens today at 5 PM and again on the 6 PM news. The Reporter did not finish her interviews until nearly 3 PM so we did not have much time to get this notice out.

Channel 4, the Reno Gazette, and the Bonanza will all be at the hearing tomorrow morning to televise and report on the Norm Azevedo's presentation to the Board of Equalization and, if there is time for any appeals, will report on those as well. It looks like this issue is going to generate some good media attention, which is exactly what we need as we proceed through the appeal process and down the road when we begin a legal challenge.

We again invite and encourage everyone in the Village to attend Norm Azevedo's presentation starting tomorrow morning at 9 AM in the County Administration Center at 9th and Wells, in the County Commissioners Chambers. Also want to mention a suggestion from our attorney, that we need to exercise our best behavior, this hearing should be viewed like a court trial and we should maintain proper decorum while Norm is making his presentation. (No clapping or Boing ...if we can manage to control ourselves :-). *This won't be easy for me!*

Also attached is the hearing agenda for next Thursday the 27th, enclosed here as an as an attachment.

Hope to see you all there tomorrow morning.

Exit 395 to Highway 80 West.

Upon entering Highway 80 heading towards Sacramento take the Wells Ave, first exit on the right, continue down the off ramp to a stop on Wells Ave.

Turn Right on Wells (north)

Continue North to the first signal light. (This will be 9th Street)

Turn right on 9th Street. (You will see the County Administration building on your left)

Continue East on 9th street for half a block.

Turn left into the entrance of the County Administration parking lot.

The hearing will be in County Commission chamber in the Administration building. (First building on your left as you enter the parking lot)
